School in CTE Shop/Laboratory Facilities

Personal safety of students in school shops and laboratories is dependent upon adequate facility, instruction, and oversight factors. Shop and laboratory safety includes the following five (5) accident classifications identified within the Bureau of Labor Statistics (BLS), Occupational Injury and Illness Classification Manual:

- 1. Contact with objects and equipment
 - Includes accidents resulting from caught-in or struck-by; struck by a falling or flying object. A person
 can be struck by flying objects from machines without protective guards. Parts of a body may get caught
 in or struck by exposed moving parts if machines are not properly guarded, or not locked out when
 being repaired.
- 2. Slips, Trips & Falls
 - Includes accidents resulting from poor housekeeping, slippery floors, inadequate fall protection, or unsafe ladders or scaffolds.
- 3. Bodily reaction and exertion
 - Includes accidents resulting from lifting, pulling, pushing, turning, wielding, holding, carrying, or throwing, and repetitive motion.
- 4. Exposure to harmful substances or environments.
 - Includes exposure to harmful substances or environments, contact with electric current, contact with extreme temperatures, exposure to noise, etc.
- 5. Fires and Explosion
 - Includes possible burns, ignition of clothing, etc.
